If the 5<sup>th</sup> should fall on a Saturday, Sunday, or holiday; the payment will be due on the following business day. I understand that my child will be considered unregistered for child care at the YMCA and will not be able to attend until the payment is collected in full. Further, any cancellation must be submitted in writing two weeks prior to the start of a new month. If this is not done, the parent is responsible for that month's payment.***
